### LASALLE COUNTY ROAD BORING PERMIT

Approval of this Permit is given with the understanding that \_\_\_\_\_, their/his successors, grantees and assigns agree to the following conditions at said property owner's expense.

- No. 1 The crossings of all county highways shall be augered or bored.
- No. 2 It will be the responsibility of the permit holder to secure a bid from an independent contractor to do the boring according to the guidelines of this permit.
- No. 3 Casing shall be pushed or bored under the highway and shall extend from right-of-way line to right-of-way line.
- No. 4 Diameter of road boring must not be less than 12". Depth of bury shall be a minimum of 36". Casing shall be SDR 26 PVC or heavier.
- No. 5 LaSalle County assumes no responsibility for maintaining the tile or for the free flowage there from.
- No. 6 The property owner is to check for buried utilities on the right-of-way and contact the proper companies.
- No. 7 When the performance of the work called for in this permit will in any way interfere with or obstruct traffic on said highways there shall be provided the necessary flagmen as required by the Statutes when one-way traffic is involved and otherwise mark said work so as to protect the traveling public.
- No. 8 Roadside signing shall comply with "Manual on Uniform Traffic Control Devices".

- No. 9 If an open pit is within 12' of the edge of pavement and left unattended there shall be placed a Type I barricade with a flasher unit on the shoulder and not removed until the pit is backfilled.
- No. 10 Said property owner, its successors, grantees and assigns shall assume all risks and liabilities for all accidents and damages that may occur to persons or property on account of work done here under.
- No. 11 Said property owner shall notify the LaSalle County Highway Department at least forty-eight (48) hours in advance of starting work covered by this permit.
- No. 12 The facilities covered by this permit shall be constructed within one (1) year after date of approval, unless extended by LaSalle County in writing.
- No. 13 Should the construction and operation of the highways require any alterations or changes to said facility within the existing right-of-way for an improvement of a County Highway, the alteration or change of location shall be made by the property owner at his expenses upon written request by LaSalle County.
- No. 14 Include a drawing of the planned boring.

No. 16 No work shall proceed on the right-of-way unless a copy of the valid construction permit is on the job site and an indemnifying bond in the amount of \$20,000.00 is filed with the County Clerk by the Contractor/Owner.

No. 17 In the event that damage should occur to any portion of the roadway as a result of construction or otherwise the Contractor/Owner shall make repairs so that the road will be passable pending permanent repairs if said damage occurs from work performed by or caused by their facilities. If said damage is not repaired within seven (7) days as per State specifications, the County Engineer may, with the approval of LaSalle County, repair said damage at the expense of said Contractor/Owner and in the event said payment is made as required, the County may collect said payment fee from the indemnifying bond. No further permits will be issued to the permittee until payment is made.
