GENERAL PROVISIONS

The words <u>"1 ½ Ton Dump Truck"</u> shall appear on the outside of the sealed envelope. If mailing the bid, the marked & sealed envelope shall be inside a mailing envelope. Emailed bids <u>Will Not</u> be accepted. All submitting bidders are cordially invited to attend this meeting.

No charges will be allowed for taxes from which LaSalle County Highway Department is exempt. The LaSalle County Highway Department is not liable for Illinois Retailer's Tax, Service Occupation Tax, Service Use Tax, and is exempt from Federal Excise and Transportation Tax.

No Bid will be allowed to be modified in any way after the deadline for the opening.

LaSalle County Highway Department reserves the right to accept or reject any and all bids and to waive technicalities. The LaSalle County Highway Committee and the County Engineer will notify the Person, Firm or Corporation of the Award to furnish the equipment.
